Tips for handling needles and syringes*

When you handle needles and syringes, you must maintain aseptic technique at all times to prevent contamination and potential for infection for your patient.

- The shaft, bevel and hub of the needle and tip of syringe (Fig. A) should be kept sterile.
- Immediately after use, place used needles into a puncture-proof sharps container.
- Do not recap used needles to avoid risk of contaminated needlesticks.



